Terms and conditions for Missing People events.

Registration

1. You understand you are registering for Light The Way DIY (the “Event”). The event is organised by Missing People (“Missing People Ltd”). Missing People Ltd is incorporated in England and Wales. Registered office is at the address - Roebuck House, 284 Upper Richmond Road West, London SW14 7JE. Registered Company No. 2814202. Registered Charity in England & Wales ([1020419](#)) and in Scotland (SC047419).
2. You must be aged 18 and over to register for the event as an individual. All participants under 18 year must be accompanied by an adult at all times.
3. You may participate in the Event as an individual subject to the Event instructions, which can be found at (<https://light-the-way-missing-people.raiselysite.com/>) We reserve the right to not accept any registration for the Event in our absolute discretion.
4. Should you wish to make any changes to your confirmed booking, you must notify Missing People as soon as possible in writing. Whilst we will endeavour to assist, we cannot guarantee all change requests.

Health & Safety

1. It is each Participants own responsibility to assess their fitness and to ensure they participate only if sufficiently fit and will check with your doctor to ensure you are medically fit to participate in the Event.
2. You acknowledge that taking part in this activity is entirely at your own risk. You agree that you will not hold Missing People or any of its representatives, employees, volunteer, trustees, persons connected to the trustees, officers or professional advisors of Missing People responsible for any injury, death or loss that might occur as a result of your participation in the Event.
3. Missing People will not facilitate participants meeting up with other participants to take part in the Event. It is advised any participants that do meet up together are taking part in the Event at their own risk.

Online Security

1. If broadcasting your Event activity via social media, such as Facebook, Instagram, Snapchat, Twitter, TikTok, YouTube or any such site or social media platform, you shall not upload, post, email or otherwise transmit or publish any context that is unlawful, harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, libellous, invasive of another's privacy, hateful, or racially, ethnically or otherwise objectionable. You must agree to delete any content which we reasonably consider to be in breach of this conditions.

Fundraising

1. You agree that carrying out all fundraising for the benefit of Missing People.
2. If you choose to not participate in the Event or we prevent you from doing so (including where the Event is cancelled for any reason) all sums collected or pledged will still be payable to Missing People.
3. To claim walk incentive(s), you must abide by the following:
 - a. You must have raised the fundraising goals, (excluding Gift Aid) outlined for the challenge incentives within two weeks of the challenge end date to be eligible;
 - b. If you are eligible for fundraising incentives, it is your responsibility to provide Missing People with the appropriate information (e.g. t-shirt size, address. <https://light-the-way-missing-people.raiselysite.com/>)
4. You will only use lawful methods to fundraise for Bloody Cancer UK and will comply with the advice given in the fundraising pack but specifically you will:
 - a. Not raise money by carrying out house to house collections
 - b. Obtain Missing People's written context before collecting in any public place. You will also need to obtain a collector's license from the responsible local authority (usually local council or police) and to make it clear that you are not an employee or agent of Missing People.
 - c. Not conduct any collection on private property (including shops, pubs, etc) without first obtaining the permission of the owner;
 - d. Not conduct any raffle or lottery without first obtaining written consent from Missing People.
 - e. Not shake a collection tin or bucket, as this is prohibited by law;
 - f. Not do anything which will or likely to bring the name or reputation of Missing People into disrepute;
 - g. Contact the charity well in advance of putting on a public event, and ensure the Event and all their parties involved are fully insured;
 - h. Obtain all fundraising partials and logos directly from Missing People, and not reproduce Missing People's logos or name without Missing People's express permission
 - i. Indemnify Missing People and keep Missing People indemnified from and against any and all loss, damage or liability (whether a criminal or civil) (including, without limitation, legal fees and costs) incurred by Missing People resulting from a breach of this Agreement by you or any other act or omission by you.
5. Your data will be processed and held in accordance with Missing People's data privacy policy.

Data Protection

1. You agree to Missing People storing information that you provided on their database and that it may be used by Missing People in accordance with the prevailing legislation and our Data Protection policy.
2. Missing People will use the information provided to you to manage the Event and your involvement in it.
3. Missing People will keep you up to date with Missing People activities or provide any other information in accordance with your stated preferences.

Cancellation and refunds

1. We will use all reasonable endeavours to ensure that the Event takes place so far as reasonably possible in accordance with the information provided on the Missing People website. However, we do reserve the right to cancel, postpone or make such alterations to the Event as we may reasonably require without any liability to you.
2. If you do not take part in the event, any funds you have raised will be treated as donations unless your sponsors contact Missing People directly for a refund.
3. Missing People reserves the right to amend these Terms and Conditions and any of the rules, guidelines or policies mentioned herein without notice.
